## Managed Investment Trust Notice for Custodians and other Intermediary Investors

GARDA Capital Limited (**GCL**) and GARDA Funds Management Limited as responsible entity of GARDA Capital Trust (**GCT** or **Fund**) together form a stapled security comprising a share in GCL and a unit in GCT, considers the Fund is a managed investment trust for the purposes of Subdivision 12-H of the Taxation Administration Act 1953 (Cth) (Act) in respect of the year ending 30 June 2018.
